Annua Report 2015/2016

Healthwatch Worcestershire is an independent organisation. We are not part of the NHS or Worcestershire County Council (WCC).

We ask people what they think about health and social care services. Then we tell the people who run or pay for the services what people think needs to be changed.

We make sure that local decision makers and health and care services put the experiences of people at the heart of their work.

Over the year we had contact with more than 5,500 people across Worcestershire.

- We have been to lots of different events and meetings around the county to tell people about Healthwatch and ask what they think.
- We invited speakers and gave people a chance to have their say at our Annual Conference and 4 of our Board Meetings held in public in different parts of the County.
- We have carried out surveys and organised groups to talk about issues.

We have made a special effort to reach out to:

- Young People and Parents of Children Under 5, supported by Young Solutions. We heard views from young homeless people and young carers as part of this work.
- People from Black, Asian and Minority Ethnic Communities, supported by Age UK Herefordshire and Worcestershire.
- Older people through events like the Retirement Roadshows, Older Peoples showcase and visiting residential and nursing homes.

During 2015/16 we have gathered over 1,700 experiences from patients, service users and carers.

Our Reports and Recommendations in 2015/2016

We have used the information people have told us to decide which areas of health and care to find out more about. We have produced Reports and Recommendations on:

- Adult Mental Health and Wellbeing
- Young People's Access to GP Services
- Child and Adolescent Mental Health Services
- Parents and Carers of Children Under 5

- Older people living in residential and nursing homes - we visited to see how residents are involved in the running of their home and the activities they enjoy.
- Our Reports have been sent to the organisations who run the services; the Clinical Commissioning Groups (CCGs) and Worcestershire County Council (who are responsible for planning and paying for health and care services), and NHS England.

Did You Know?

We carried out a survey of the older people's care and nursing homes that we have visited over the last two years. The majority told us that they had done the things we recommended in our Reports and our visits had made a difference to activity in the home.

Did You Know?

Our Report on Mental Health and Wellbeing has been used to train staff and develop the ideas behind the new Wellbeing Hub and the Peer Supporter Service, in particular making sure that staff include the values of listening, treating people with warmth and compassion and ensuring that people's needs are met. The Report is also being used to help with the redesign of secondary care services, for people who need more care and support.

Making sure people are involved in planning and reviewing services

You told us people and health and care services must work alongside each other as equals. This is called co-production. When you see a health or care professional they should ask your views and opinions, so you can have a real say in your care. When services are changing, people should be told and involved from the start, so their ideas can help decide what happens next.

Did You Know?

Our Chair, Peter Pinfield, sits on Worcestershire's Health and Wellbeing Board (WHWB). They set priorities and make decisions about health and care in Worcestershire. Peter acts as the patient and service user voice, taking the experiences that we collect and our Reports and Recommendations to the Board. For example the Board agreed to our recommendation that health and care organisations across the County should work with patients, service users and carers as equal partners.

We have been checking that people are **involved in how services could be changed for the future** such as:

- How hospital services will be organised across the County -Future of Acute Hospital Services in Worcestershire (FoAHSW).
- Plan for how health and care services in Worcestershire and Herefordshire can work closer together - Sustainability and Transformation Plan.
- How health services (e.g. GP services) are delivered in the community - Primary Care Delegated Commissioning.
- We have sent in your views about 12 local and national issues that you have told us are important. For example we replied when the House of Commons Select Committee on Health asked for views about Primary Care (e.g. GP) services.

Improving the quality of health and social care

You have told us that patient safety and high quality health and social care services are really important. We check this by:

- Looking at how local health and care services are doing against national targets and standards (e.g. through commenting on NHS Quality Accounts).
- Checking how patients are kept safe, and that any concerns are dealt with - through formal meetings of Worcestershire's **Clinical Commissioning Groups** and NHS England.
- Providing information to Councillors on the County Council's committees which look at health services and social care
