#### **HWW's Reports**

# HWW's report of Peoples Experiences of the Educational, Health and Care Plan

During Q3 HWW launched a survey to evaluate parent carers experiences of the Educational, Health and Care Plan assessment process. The survey ran throughout Q3 and the analysis to prepare a summary report with recommendations was prepared for publication before the end of Q4. Whilst the report was shared as a confidential draft with commissioner and providers it's formal approval and publication was delayed by the 'purdah period' associated with the County Council elections given the topical and potentially controversial nature of the subject.

The report will be formally approved and published at HWW's Public Board Meeting on 22 May 2025.

#### **Quality and Safety**

During the period under review HWW continued to attend meetings associated with the oversight of quality and safety across the Integrated Care System.

These included:

- ICB Quality and Safety Group, Resources and Delivery Group and the Worcestershire Place Partnership ICS - Elective, Cancer and Diagnostics Programme Board
- WAHT Clinical Governance Committee
- HWHCT Quality & Safety Committee and Mental Health Collaborative
- WCC- HOSC, Children & Families Scrutiny Panel, Adult Scrutiny Panel





During Q4 HWW influenced the following actions to improve Quality and Safety:

#### • Dental services

HOSC received a report from NHS Herefordshire & Worcestershire ICB about the NHS dental services recovery plan in Worcestershire. Following representation from HWW the Committee asked the ICB to improve communications with the public about access to dental services with a focus on urgent treatment.

#### • NHS Accessible Information Standard

In continuing HWW's focus on influencing the implementation of the NHS Accessible Information Standard with a view to improving the strategi leadership of the issue HWW made a presentation at the Worcestershire Place Partnership which led to an invitation to present at the ICB's Inequality Ambassadors Group meeting. At that meeting the ICB's Director of Strategy agreed to take on responsibility for leading the implementation of the Standard.

HWW will continue to use patient experience to monitor and improve compliance with the Standard.

### 'Partnership for Inclusion of Neurodiversity in Schools [PINS] Following HWW's representation to the ICB and Worcestershire County Council about the shared decision of the ICB and Worcestershire Children's First to invest the totality of the Government grant to fund the

Children's First to invest the totality of the Government grant to fund the PINS project in schools in Herefordshire the ICN have confirmed to HWW that the 2025/26 grant will be invested in Worcestershire schools. This will support schools in the early management of neurodiverse children with the potential to reduce demand for specialist services.

#### Child and Adolescent Mental Health Services [CAHMS]/Adult Mental Health Services

In response to patient and carers requests for advice and information about accessing both CAMHS and Adult Mental Health services HWW made a request to the Health and Care Trust as the provider of the services for the specified eligibility criteria/thresholds for accessing those services. It transpires that contractual service specifications do not exist for either service. HWW continues to pursue its request for this information with the Trust.

The ICB informed HWW that it was making a quality assurance visit to CAHMS in response to the patient/carer experience of the service HWW had shared with the ICB. HWW expects to receive the outcome of the visit in Q1 of 2025/26.

#### Adult ADHD Pathway

HWW continues to liaise with the ICB about the provision of a functioning Adult ADHD pathway. Following feedback from HWW the ICB has acted to address concerns that patients with a diagnosis and in treatment were being required to await a re-assessment if the new pathway required them to move between providers.





#### Hospital Discharge

HWW continues to pursue the improvement to the process of hospital discharge and have shared feedback with the Acute Trust feedback from the Registered Managers of Worcestershire's care homes as to how discharge from its hospitals could be improved. The Trust is now meeting with Registered Managers.

#### Regional/National

#### **Healthwatch England**

HWW has continued to participate in the West Midlands Local Healthwatch Network and represents the Network at the West Midlands Cancer Alliance Board.

HWW continues to participate in a regional study to evaluate the Learning from Integrated Care Systems/HWBB Development in the West Midlands.

#### International Foundation for Integrated Care

HWW has been invited by the International Foundation to help shape the 2026 International Conference on Integrated Care which is being held in Birmingham.
